All external contributors should be selected and verified by the Project Coordinator "Open Sign" in order to confirm their reliability and integrity, complying with all legal requirements, listed in the legal framework.

If you want to provide new content, you must also comply with the content creation guidelines. All documents (thematic videos, manual activities, educational sheets and games) should be documents that help teachers in their daily professional practice and foster deaf pupil's inclusion.

Please note that you may not be able to upload new content if you have not completed this consent form.







IV - LEGAL FRAMEWORK

- 1. Do not use the platform for illegal activities or to promote dangerous and illegal activities;
- 2. Do not transmit viruses, malicious programs or any other malicious or destructive code. Do not post content that could harm or interfere with normal operation of the platform;
- 3. Do not distribute sexually explicit or pornographic material. Do not redirect to commercial pornographic sites;
- 4. Do not post violent content;
- 5. It is your responsibility to obtain the necessary consent from the legal guardians of minors (children under the age of 18)
- 6. Any additional resources need to be copyright free.
- 7. Total free admission for participation in Open Sign: users can have full access to all Open Sign resources, without any financial obligation;
- 8. Our publications are under the Licenses Creative Commons 4.0 Attribution Non-commercial use Share Alike: Here, you are able to utilise all resources (ebooks, texts, images, videos, etc.) created by the Open Sign team for your own courses, trainings, conferences, theses, etc, as long as you refer to our resources as your main source; you are prohibited from using the resources for any commercial purposes (resale or registration fee); and if you release the resources as they are or modified under the same conditions.
- 9. To personalize the user experience, Open Sign platform collects personal data: users' names, email addresses and content viewing preferences. These information are protected in the database by encrypted passwords and are deleted if a user chooses to unsubscribe. In addition, anonymous statistics about visits (number, recurrence, duration) and downloads are provided to the French National Agency of European Union for project monitoring. The Google Analytics service is used to create some of these reports.
